1. PREFACE

3. STUDENT RIGHTS

- 3.2 The right to be respected and valued
- 3.3 The right to express ideas and opinions in a positive way, and to be listened to
- 3.4 The right to feel safe all of the time
- 3.5 The right to have fair access to School resources, including access and exposure to all aspects of the WA Curriculum

With these rights, also comes responsibilities. These include some very important rules that underpin all student conduct at OneSchool Global WA. These responsibilities are to be understood and adhered to at all times.

5. POSITIVE BEHAVIOUR

OneSchool Global WA Ltd takes appropriate action in response to behaviour that is detrimental to themselves or others, or to the achievement of high quality teaching and learning. There is a large focus on *Restorative Practice* conversations, with an emphasis on relationships, ensuring that students are aware of their behaviour and how it can impact on their peers and staff.

Behaviour contrary to the Student Code may result in disciplinary action including (but not limited to) detention, suspension or exclusion from school activities, in accordance with our *Positive Behaviour Policy*. Students should also acknowledge and understand that serious offences such as assault, theft, wilful damage and other unlawful activities are highly likely to attract a suspension, in accordance with our *Serious Breaches Policy*. Students should also be aware that where a student's conduct breaks the law, the matter will be reported to the Police, in addition to any action taken by the School for such offence.
